16.05 Comments on the Rotherwick Plan

DW reported that the letter to Rotherwick, a copy of which had been circulated with the agenda, had been sent by email to John Bennett, but no acknowledgment had been received. DW was asked to check that it had arrived. RL said that he would be attending the next Rotherwick Parish Council Meeting.

16.14 Budget

AA reported the latest position with the budget.

16.15 Response to the Hart District Plan Consultation

- 16.15.1 BD will respond with our preferences to Questions 3 and 4 but will not rank the Hook sites as we have not consulted the community.
- 16.15.2 JW reported that she had contacted Ranil Jayawardena MP ("RJ") regarding self-building. Her query had been referred to Daryl Phillips ("DP") of Hart District Council. RJ sent her a copy reply from DP recording that there are 27 individuals on Hart's self-build register and referring to the question in the consultation "where are the sites in Hart that you think may be appropriate for custom and self-build homes?".
- 16.15.3 It was noted that Hart District Council are now working with East Hants. Regulation 19 comments will go to the Inspector (i.e. after May).

16.16 Policies

- 16.16.1 LB's draft **Policies** V3 had been circulated prior to the meeting and LB took the members through the document and her queries. LB will produce a further draft for the next meeting. Some of the points requiring action are:
- 16.16.2 Everyone is asked to consider what evidence will be required and check whether anything has been left out.
- 16.16.3 Clarification is needed of what is meant by "Beating Heart" or suggest alternative wording clearly representing what this means.
- 16.16.4 A list of all green spaces, large and small, with a map must be prepared.
- 16.16.5 AA spoke of pressure for a satisfactory cycle route from Hook to Hartley Wintney, which would, of course, include Murrell Green, and possibly the Leisure Centre.
- 16.16.6 A map of key services is required, including all current cycle routes both official and unofficial.
- 16.16.7 It was noted that the biodiversity report needs to be updated to include Holt Park.
- 16.16.8 A query was raised regarding building policies if there is no site selection. LB confirmed that density cannot be challenged but "generic" policies can be included to relate to any sites that might be "added" after the HNP has been finalised.
